**CHECK IN HALF HOUR PRIOR TO START TIMES.**

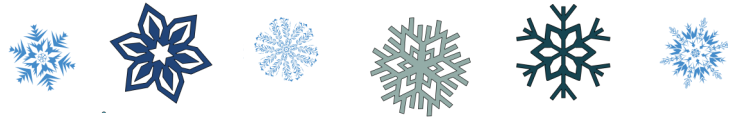
**DIVISIONS:** Players are eligible to enter a maximum of 2 divisions, one gender and one mixed division.
